Moving Forward Together

Our budget proposal for the coming year takes into account the strong possibility

of drastically reduced financial aid from the state and also the potential and unknown costs of reopening our buildings during this pandemic. It also preserves all of the following important initiatives for our students:

• Small class sizes at the elementary level

• Instrumental music beginning in the fourth grade

• A wide range of course offerings at Beacon High School including seven AP courses and seven Dutchess Community College courses

• A strong athletics program with many offerings from modified to the varsity level

• Clubs and extracurriculars at all levels of school

• 1:1 Chromebook initiative for all of our students

If the budget vote does not pass, the district would have to implement a contingency budget. This contingency would force us to make \$1.3 million of cuts across all areas of the district and it would have a negative impact on the student experience in our district.

The Beacon City School District community has been powerfully supportive of our efforts the past few years and that support has enabled us to make very positive strides as a school district.

We will work very hard to continue to make positive steps during this difficult time and beyond.

The annual budget vote for the fiscal year 2020-2021 by the qualified voters of the Beacon City school district, Dutchess County, New York, will be held by absentee ballots only on Tuesday, June 9, 2020. All ballots must be received by the Beacon City School District by 5:00pm Tuesday June 9, 2020.

¹ The basic school tax relief (STAR) exemption is authorized by section 425 of the Real Property Tax Law.

Contingency Budget: What if the Budget Does Not Pass?

If the budget **does not pass** and goes to contingency, 'cost of living' increases are **not allowed**. Therefore the operating budget would have to be **cut by \$1,302,053**. Since other costs have increased, this would mean **significant cuts in programs and activities**, which may include:

- Cap class sizes at 35
- Eliminate non-core classes such as art, music and electives
- Cuts to Athletics, Clubs, and Student Activities at all levels
- Cut non-mandatory equipment purchases
- Charge full cost of facility use to all non-school organizations
- Reduce/eliminate school related building use after hours
